Spotlight: Missing Millions Research

Across the world, economies continue to grapple with the ongoing changes the fourth industrial revolution is bringing to the workplace.

Our research examines the untapped potential of the working age population and considers important points on workplace training, and the investment needed in skills to help people flourish throughout the entirety of their careers.

To put this untapped potential into context, 60% of people feel their skills are being under utilised 50% of the time, which equates to 31.3 million people in the UK workforce.

This lack of opportunity for skills development has led to only a third of the UK workforce feeling positive about their future career prospects.

Our research also found:

- Over a quarter of the population received no workplace training for at least a decade, and almost half have not received training for at least 3 years.
- Those working part-time, significantly more women than men – were also less likely to have received training in the last five years than those working full-time. Part-time workers were additionally far less likely to believe there was opportunity to progress than their full-time counterparts (22% vs 36%).
- Those living in the North East of England faced a significant disadvantage in access to training and opportunities for progression when compared with other regions. Only 21% of people in the North East felt positive about the jobs market in their local area, compared to 45% in London.

In order to gain approval we will require you to complete a Qualification Approval Form on Walled Garden including details of the delivery staff and their occupational competence and then submit along with the following supporting evidence for each level:

- a lesson plan for one unit and the support resource e.g. slide deck
- learner journey/delivery plan your assessment strategy.
