Can you give an overview of changes to the Assessment Plans for Team Leader?	The Assessment Methods will change to a presentation with Q&A and Professional Discussion underpinned by a portfolio of evidence. The portfolio will not be assessed and there will no longer be an online test.
When will we be able to go forward with the new EPA for team leader? Where can we find information on changes?	The new Assessment Plan for Team Leader will be available to new apprentices and existing apprentices provided they have not commenced the current assessment plan. We will aim to get this introduced at the earliest opportunity, but cannot move forwards until IfATE have published the new Assessment Plan.
