# Last chance for free conversion of Coaching and Mentoring qualifications

We'd like to remind customers that following the retirement of the 2012 coaching and mentoring qualifications on Sunday 30 June 2019, all new registrations must be on the current 2018 versions.

Customers who previously had approval to deliver the 2012 qualifications are currently eligible for a free like-for-like conversion to the new coaching and mentoring qualification.

If you have not converted to the new qualifications by 31 October 2019, you will no longer be eligible for a free conversion and the usual add on approval process and fee will apply.

In order to beat the cut-off date, please download and complete the form and return it to us as soon as possible.
